DUFABLE POWER OF ATTORNEY

In deciding whether to disclaim, my Agent shall consider the effect of disclaimer on taxes that may be payable, on qualification for government benefits, and on my existing estate plan.
- 5. Gifts. Make gifts on my behalf to or for the benefit of my agent, my agent's wife, or my agent's lineal descendants.
