was sold to Klamath County, Oregon, subject to redemption by Defendant M. F. Keller; and

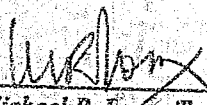

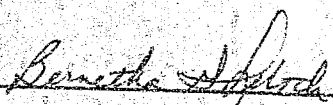

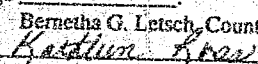
