

MTC 42015-M9

This is a MILITARY POWER OF ATTORNEY prepared pursuant to Title 10, United States Code, Section 1044b, and executed by a person authorized to receive legal assistance from the military services. Federal law exempts this power of attorney from any requirement of form, substance, formality, or recording that is prescribed for powers of attorney by the laws of a state, the District of Columbia, or a territory, commonwealth or possession of the United States. Federal law specifies that this power of attorney shall be given the same legal effect as a power of attorney prepared and executed in accordance with the laws of the jurisdiction where it is presented.

SPECIAL POWER OF ATTORNEY

KNOW EVERYONE BY THESE PRESENTS, which are intended to constitute a Special Power of Attorney, THAT I, CODY SMITH, having an address at P.O. Box 542, Klamath Falls, Oregon 97601, my attorney-in-fact TO ACT in my name, place and stead in any way which I could do, if I were personally present, to the extent that I am permitted by law to act through an agent:

(a) To act for me and in my name, place and stead, to execute any and all papers in connection with the purchase of real property located at ~~83225~~ Petersteiner Road, Bonanza, Oregon including, but not limited to, Deed of Trust, Deed of Trust Note, Financing Statement, Security Agreement and declaration of Acceptance; and to do, execute and perform all other acts, in law needful and necessary to be done in and about the premises, as fully, largely, and amply, to all intents and purposes whatsoever as I might or could do if acting personally, and I hereby ratify and confirm all lawful acts done by my said Attorney in Fact by virtue hereof.

This power of attorney, however, shall terminate on December 31, 1997.

To induce any third party to act hereunder, I hereby agree that any third party receiving a duly executed copy or facsimile of this power of attorney may act hereunder, and that revocation or termination hereof shall be ineffective as to such third party unless and until actual notice or knowledge of such revocation or termination shall have been received by such third party, and I, for myself and my heirs, executors, legal representatives and assigns, hereby agree to indemnify and hold harmless any such third party from and against any and all claims that may arise against such third party by reason of reliance upon this power of attorney.

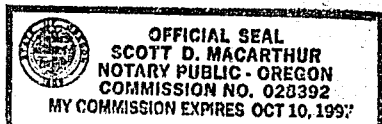
