In Witness Whereof the said vendor has executed this memorandum September 4, 1997.

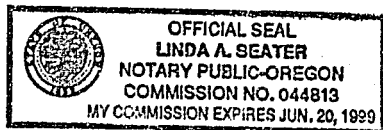
