DEED OF RECONVEYANCE

KNOW ALL MEN BY THESE PRESENTS, that the undersigned trustee or successor trustee under that certain trust deed dated April 23, 1996; March 11, 1997, executed and delivered by Herbert A. 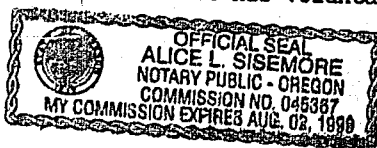
