0 1. NATURE OF THE REQUEST:

The applicant wishes to establish a non-farm home on 1.74 acres zoned FR. This request was heard by the Hearings Officer on 6 September 5, 1997, pursuant to ordinances 44 and 45. The request was reviewed for conformity with Land Development Code Articles 54

NAMES OF THOSE WHO PARTICIPATED: 2

The Hearings Officer in review of this application was Neal G. Buchanan. The applicant appeared and offered testimony in support of the application. The Planning Department was represented by Carl Shuck, and the recording secretary was Karen Burg.

3. LOCATION.

The property under consideration is generally located north and east of Rails to Trails and the Sprague River Highway, immediately adjacent to the town of Sprague River, Klamath County, Oregon. It is legally described as a portion of the NW 1/4 NW 1/4 Sec. 14, T 36S R 10 EWM. The tax account number is 3610-14BB-1800.

RELEVANT FACTS: 4.

The applicant wishes to establish a residence not in conjunction with farm use on a 1.47 acre remnant parcel zoned FR. This application is processed in accordance with non-farm criteria. As it is less than the 80 acre minimum required by the Code, it is not within a Goal 5 overlay, and it has soil or topographic constraints prohibiting its inclusion within an area of commercial agriculture. The property is not under farm use deferral.

5. FINDINGS:

All evidence submitted as the Staff Report and Application (Exhibits A and B) and offered testimony show that the approval criteria as set out in Code Article 54 has been satisfied.

6. ORDER:

Therefore, it is ordered that the request of Stan Kremis for CUP 69-97 is approved subject to the following conditions:

1. The applicant shall file a restrictive covenant with the County Clerk prohibiting the permit holder and their successors in interest from filing complaint concerning farm and forest operations consistent with accepted farm practices and the Oregon Forest Practices Act on nearby lands.

2. This CUP will expire two years from the date below unless utilized or an extension is approved by the Planning Director.
