more particularly described as follows:



singular includes the plural.

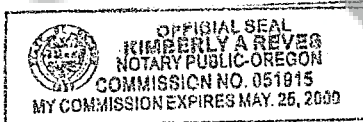


