

KNOW ALL MEN BY THESE PRESENTS, that the undersigned trustee or successor trustee under that certain trust deed dated February 24, 1997, executed and delivered by Oswaldo S. Ayala & Josefina R. 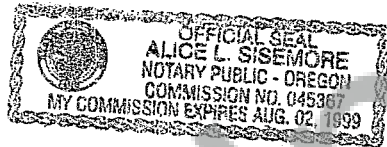
