THIS INDENTURE Made this 9th day of October, 1997, by and between David Wayne Skelton the duly appointed, qualified and acting personal representative of the estate of Boyd M. Skelton, deceased, hereinafter called the first party, and Randall E. Griffith and Connie M. Griffith husband and wife hereinafter called the second party; WITNESSETH:

For value received and the consideration hereinafter stated, the receipt whereof hereby is acknowledged, the first party has granted, bargained, sold and conveyed, and by these presents does grant, bargain, sell and convey unto the second party and second party's heirs, successors-in-interest and assigns all the estate, right and interest of the deceased at the time of decedent's death, and all the right, title and interest that the estate of the deceased by operation of the law or otherwise may have thereafter acquired in that certain real property situated in the County of Klamath, State of Oregon, described as follows, to-wit:

The West 75 feet of Lots 46 and 47 of YALTA GARDENS according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon.

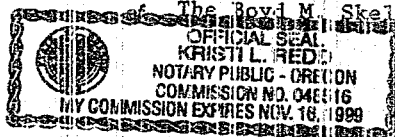
