DECLARATION OF ANNEXATION TO VACATION OWNER PROGRAM

(WORLDMARK, THE CLUB - THE RUNNING Y RANCH RESORT)

(Units 109, 110, 209-214, 309-316, 404-409 and 501-505)

THIS DECLARATION OF ANNEXATION is made October 15, 1997, by TRENDWEST RESORTS, INC., an Oregon Corporation ("Declarant"), WORLDMARK, THE CLUB, a California Non-Profit Mutual Benefit Corporation ("Club" or "Co-Declarant") and RUNNING Y RESORT., an Oregon corporation ("Owner").

A. Property. Owner is or was the equitable owner of all of the property specifically described on Exhibit A attached hereto and incorporated herein (the "Property"). The Property was or will be transferred at Declarant's direction from Declarant's contract vendor directly to Club as owner. In addition, Club owns the property covered by the "Declaration" described in Paragraph B below.

B. Declaration. Declarant and Co-Declarant previously recorded a Declaration of Vacation Owner Program (WorldMark, The Club - The Running Y Ranch Resort) dated December 23, 1996, and recorded on February 5, 1997, in Volume M97, at Page 3592 Records of Klamath County, Oregon ("Declaration"), as the same may be amended, which covers the property described in Exhibit "A" to the Declaration. Except as may be specifically modified herein, the provisions and definitions of the Declaration are hereby incorporated herein in their entirety.

C. Annexation. Declarant, Owner and Club hereby declare that from and after the date of the Declaration of Annexation all of the property is held and shall be held, conveyed, hypothecated or encumbered, leased, rented, used, occupied and improved subject to the Declaration. This Declaration of Annexation is adopted according to the procedures and authority of Restriction 8 of the Declaration.




