## TRUSTEE'S DEED

THIS INDENTURE, Made on October 17, 1997, 1997, between Dennis Fennell, hereinafter called trustee, and Harold Elliot, hereinafter called the second party;

RECITALS: Reference is made to that certain trust deed made by Todd R. Myers and Sherri L. Myers as Grantors, to Bend Title Company, an Oregon Corporation, as Trustee, in favor of Harold Elliot, as beneficiary, dated October 10, 1995, recorded October 16, 1995, in the mortgage records of Klamath County, Oregon in volume M95 at page No. 27980 covering the following described real property situated in the above-mentioned County and State, to wit:

Lot 9 in Block 3 of PLAT NO. 1204, LITTLE RIVER RANCH, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon.

In that trust deed the real property therein and hereinafter described was conveyed by the grantor to the trustee to secure, among other things, the performance of certain obligations of the grantor to the beneficiary. The grantor thereafter defaulted in performance of the obligations secured by the trust deed stated in the notice of default hereinafter mentioned, and such default still existed at the time of the sale hereinafter described. By reason of the default, the owner and holder of the obligations secured by the trust deed,

By reason of the default, the owner and holder of the obligations secured by the trust deed, being the beneficiary therein named, or beneficiary's successor in interest, declared all sums so secured immediately due and owing. A notice of default containing an election to sell the real property and to foreclose the trust deed by advertisement and sale to satisfy grantor's obligations was recorded on May 9, 1997, Volume M97 page 14197 of the Klamath County, Oregon, Mortgage Records.

## The true and actual consideration for this conveyance is \$21,400.00.

After recording the notice of default, the undersigned successor trustee gave notice of the time for and place of sale of the real property as fixed by the trustee as required by law. Copies of the notice of sale were served pursuant to ORCP 7D.(2) and 7D.(3) or mailed by both first class and certified mail with return receipt requested, to the last known address of the persons or their legal representatives, if any, named in ORS 86.740(1) and (2)(a), at least 120 days before the date the property was sold. A copy of the notice of sale was mailed by first class and certified mail with return receipt requested to the last known address of the guardian, conservator or administrator or executor of any person named in ORCP 86.740(1), promptly after the trustee received knowledge of the disability, insanity or death of any such person. The undersigned successor trustee on October 17, 1997, in accord with the standard of time established by ORS 187.110, which was the day and hour in the notice of sale, and at the place so fixed for sale, in full accordance with the laws of the State of Oregon and pursuant to the powers conferred upon the trustee by the trust deed, sold the real property in one parcel at public auction to the second party for the sum of \$21,400.00, the second party being the highest and best bidder at the sale and that sum being the highest and best bid for the property. NOW THEREFORE, in consideration of that sum so paid by the second party in cash, the

receipt whereof is acknowledged, and by the authority vested in the trustee by the laws of the State of Oregon and by the trust deed, the trustee does hereby convey unto the second party all interest which the grantor had or had the power to convey at the time of grantor's execution of the trust deed, together with any interest the grantor or grantor's successors in interest acquired after the execution of the trust deed in and to the following described real property, to wit: \*\*.
