THE COMMON COUNCIL OF THE CITY OF MERRILL, KLAMATH COUNTY, OREGON intents to vacate the following described portion of a city street in said City, County and State:

That portion of Fourth Street adjacent to Lot 1, Block 8, of "The second supplementary plat to the town of Merrill, Oregon", a duly recorded subdivision, or particularly described

Beginning at a point on the north line of said lot 1 from which the northeast corner bears east 2.24 feer; thence N00 44'08" 2.71 feet; thence S89 15'52"W 64.62 feet; thence S00 44'08"E 1.88 feet to a point on the north line of said lot 1; thence east 64.62 feet to the point of beginning with bearings based on record of survey #5605.

(Said area may further be described as that portion of Deboy's house plus out to the eves wide, that is encroaching upon the city street.)

This part of the street when vacated will revert to the abutting property owner for their use. This property owner is Bonnie Deboy. This portion of Fourth Street that is being vacated will be added to the legal description of the said property.

The reason for such vacation as above described and herein requested is because 7.5 inches of the Deboy house encroaches upon the city street. (See attached copy of the 1994 survey map.) Vacating the above described property will mean that the structure does not touch the right of way of the street. Vacation of the said property will allow Bonnie Deboy clear title of her property and she can proceed with the sell of her property.

The Common Council of the City of Merrill further notes that the area being vacated will not injure or damage any property holder or owner or any other person by such vacation.
