DISTRIBUTION REGHT OF WAY EASEMENT FOR OVERHANG

For value received, Robert Barsons and Winifred Parsons (Grantor) hereby grants to Pacificorp, an Oregon comporation, its successors and assigns (Grantee), an overhang easement for a right of way twenty (20) fact in width for the construction, reconstruction, operation, maintenance, repair, replacement, enlargement, and removal of electric power distribution lines and communication lines and all recessary or desirable accessories and appurtenances thereto, including cuys and anchors, wires, filers, cables and other conductors and conduits therefor; but not including supporting towers, poles and props; along the general course now located by Grantee on, over or under the surface of the real property of Grantor in clamath County, State of Oregon, more particularly described as follows:

Said property generally located in The North Half (N 1/2) of The Northeast Quarter (NE 1/4) of Section 33, Township 39 South, Range 12 East of the Willamette Meridian, and more specifically described in Volume M78, Page 5861 in the Official Records of Klamath County.

Assessor's Map No.39 12 33 Tax Parcel No.TL 200

Together with the right of access to the right of way from adjacent lands of Grantor for all activities in connection with the purposes for which this easement has been granted; and together with the present and (without payment therefor) the future right to keep the right of way and adjacent lands clear of all brush, trees, timber, atructures and other hazards which might endanger Grantee's facilities or impede Grantee's activities.

At no time shall Grantor erects or permit the exection of any buildings or structures of any kind or nature, or place or use or permit any equipment or material of any kind that exceeds 12 feet in height, or light any fires, or place or store any flammable traterials (other than agricultural crops), on or within the boundaries of the right of way. Subject to the foregoing limitations, the surface of the right of way may be used for reads, agricultural crops and other purposes not inconsistent with the purposes for which this easement has been granted.

The rights and obligations of the parties hereto shall be binding upon and shall benefit their heirs, successors and assigns; and this easement shall terminate if and when Grantee shall have abandoned all use of the right of way and no longer has any future need therefor.
