For value received <u>McKoen Family Trust</u> (Grantor) hereby grants to PacifiCorp, an Oregon corporation, its successors and assigns (Grantee), an easement for a right of way <u>twenty (20)</u> feet in width for the construction, reconstruction, operation, maintenance, repair, replacement, enlargement, and removal of electric power distribution lines and communication lines and all necessary or desirable accessories and appurtenances thereto, including without limitation: supporting towers, poles, props, guys and anchors, including guys and anchors outside of the right of way; wires, fibers, cables and other conductors and conduits therefor; and pads, transformers, switches, vaults and cabinets, along the general course now located by Grantee on, over or under the surface of the real property of Grantor in Klamath County, State of Oregon, more particularly described as

Said property generally located in The Southeast Quarter (SE *) of The Northeast Quarter (NE *) and The Northeast Quarter (NE *) of The Southeast Quarter (SE *), all in Section 27, Township 40 South, Range 10 East of the Willamette Meridian, and more specifically described in Volume M90, Page 7179, in the Official Records of Klamath County.

Together with the right of access to the right of way from adjacent lands of Grantor for all activities in connection with the purposes for which this easement has been granted; and together with the present and (without payment therefor) the future right to keep the right of way and ad acent lands clear of all brush, trees, timber, structures and other hazards which might endanger Grantee's facilities or impede Grantee's activities.

At no time shall (rantor enect or permit the effection of any buildings or structures of any kind or nature 1 of shired or use of permit any equipment or material of any kind, that exceeds 12 teet in height, or light any fires, or place or shore any finamable material (other than agricultural crops), on or within the boundaries of the right of way. Subject to the foregoing limitations, the surface of the right of way may be used for roads, agricultural crops and other

purposes not inconsistent with the purposes for which this easement has been granted.

Indemnification clause

PacifiCorp shall incemnify and defend Grantor from any claim, loss or liability to the extent arising out of or related to; 1) any activity of PacifiCorp, is agents or contracts, on the premise or, 2) any condition of the premise arising out of the use by or possession of or control of PacifiCorp, its agants or contractors. PacifiCorp shall reimburse Grantor for any physical damage to Grantor's property or crops caused by PacifiCorp's activities.
