## EXHIBIT "A" LEGAL DESCRIPTION

If Borrower pays Funds to Lender, the Funds shall be held in an institution the deposits or accounts of which are insured or guaranteed by a federal or state agency actuding Lender if Lender is such an institution). Lender shall apply the Funds to pay said taxes, assessments, insurance precliums and ground reits. Lender may not charge for so holding and applying the Funds, analyzing said account or verifying and compiling said assessments and bills, unless Lender pays Borrower interest on the Funds and applicable law permits Lender to make such a charge. 4. Prior Mortgages and Deeds of Trust; Charges; Liens. 
