Amendment to Covenants, Conditions and Restrictions

Reference is made to the document entitled "Covenants, Conditions and Restrictions" (herein referred to as "CCRs") signed by the owners of the real property situated in the County of Klamath, State of Oregon, and described as follows: that portion of the SE1/4 SE1/4 of Section 30, Township 39 South, Range 10 East of the Willamette Meridian, lying southerly of the centerline of the No. 17 drain, northerly of the Lost River Diversion Canal, easterly of the U.S.R.S. C-G Canal and bounded on the East by Reeder Road, comprising about 9.44 acres. Said CCRs were recorded at M95, page 33236 and at M95, page 35080, deed records of Klamath County, Oregon

The undersigned, as all the owners of such real estate hereby amend article 1 in said CCRs to read as follows:

"1. Residential Construction. Residences shall be built on site. No residence may be a manufactured, modular or mobile home. The residences shall have a minimum of fifteen hundred (1,500) square feet of livable space on the ground floor. Livable space shall not include garage, patio, breezeway, storage rooms, porches, decks or similar structures."

All provisions of said CCRs not inconsistent with the above provision shall remain in full force and effect.

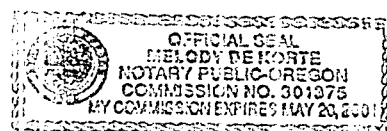

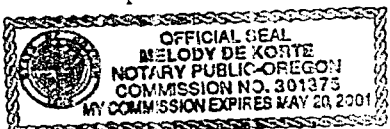

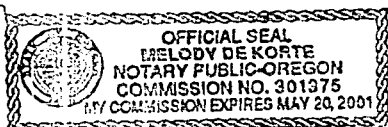
