(a) on the date next written below;

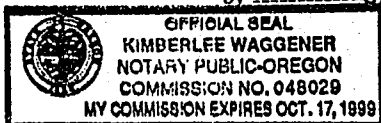
(b) ~~on the date I am adjudged incompetent by a court of proper jurisdiction.~~
