

KNOW ALL MEN BY THESE PRESENTS, that the undersigned trustee or successor trustee under that certain trust deed dated November 16, 19 92, executed and delivered by Michael D. Pearson & Denelda M. 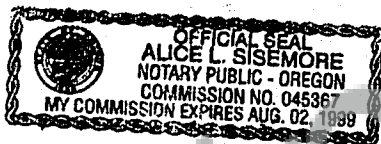
