EXHIBIT "A" DESCRIPTION OF PROPERTY

A parcel of land situate in the N $\frac{1}{2}$ SW $\frac{1}{2}$ NW $\frac{1}{2}$ of Section 11, Township 39 South, Range 9 follows:
