All wells shall be securely covered to prevent any foreign substance from entering the well.</li> <li>3. All wells shall be equipped with an access port or airline so that static water level information can be determined at any time.</li> <li>4. Well casing must be protected from damage and meet minimum extension requirements.</li> <li>5. Wells may only be permanently abandoned by a licensed and bonded well constructor or a landowner with a valid permit and bond. Well abandonment must be carried out in accordance with state rules.</li> </ul> |
