DEED OF RECONVEYANCE

KNOW ALL MEN BY THESE PRESENTS, that the undersigned trustee or successor trustee under that certain trust deed dated August 13, 1996; October 30, 1996, executed and delivered by Thomas R. 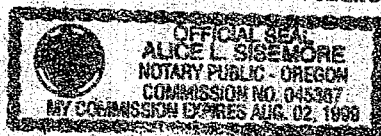
