MODIFICATION OF DEED OF TRUST

THIS MODIFICATION OF DEED OF TRUST IS DATED DECEMBER 15, 1997, BETWEEN Gayle P Nicholson (referred to below as "Grantor"), whose address is 2655 Shasta Way Suite #1, Klamath Falls, OR 97603; and South Valley Bank & Trust (referred to below as "Lender"), whose address is P O Box 5210, Klamath Falls, OR 97601.

DEED OF TRUST: Grantor and Lender have entered into a Deed of Trust dated June 19, 1996 (the "Deed of Trust") recorded in Klamath County, State of Oregon as follows:

Recorded July 5, 1996 in the office of the Clerk, County of Klamath, State of Oregon, Volume M58, Page 19945, Microfilm #20874.

REAL PROPERTY DESCRIPTION: The Deed of Trust covers the following described real property (the "Real Property") recorded in Klamath County, State of Oregon:

Parcel 8:
A portion of Tract 32 of ENTERPRISE TRACTS, situated in the NW 1/4 of Section 3, Township 39 South, Range 9 East of the Willamette Meridian, Klamath County, Oregon, more particularly described as follows:
Beginning at a 5/8 inch iron pin on the East line of said Tract 32 which bears North along said East line a distance of 180.72 feet from the Southeast corner of said Tract; thence leaving said East line, South 89 degrees 51' 50" West a distance of 119.44 feet to a 5/8 inch iron pin on the East line of Austin Street; thence North 00 degrees 20' 48" East along said East line a distance of 175.0 feet to the Southwest corner of parcel described in instrument recorded in Volume M57, page 12555, Microfilm records of Klamath County, Oregon; thence North 89 degrees 51' 50" East along the South line of said parcel a distance of 119.57 feet to the East line of said Tract 32; thence South along said East line a distance of 175.0 feet to the point of beginning.

The Real Property or its address is commonly known as 1869 Austin Street, Klamath Falls, OR 97603. The Real Property tax identification number is 3308-38A-47021.

MODIFICATION: Grantor and Lender hereby modify the Deed of Trust as follows:

Extend the maturity date to January 31, 1998

CONTINUING VALIDITY: Except as expressly modified above, the terms of the original Deed of Trust shall remain unchanged and in full force and effect. Consent by Lender to this Modification does not waive Lender's right to require strict performance of the Deed of Trust as changed above nor obligate Lender to make any future modifications. Nothing in this Modification shall constitute a satisfaction of the promissory note or other credit agreement secured by the Deed of Trust (the "Note"). It is the intention of Lender to retain as liable all parties to the Deed of Trust and all parties, makers and endorsers to the Note, including accommodation parties, unless a party is expressly released by Lender in writing. Any maker or endorser, including accommodation makers, shall not be released by virtue of this Modification. If any person who signed the original Deed of Trust does not sign this Modification, then all persons signing below acknowledge that this Modification is given conditionally, based on the representation to Lender that the non-signing person consents to the changes and provisions of this Modification or otherwise will not be released by it. This waiver applies not only to any initial extension or modification but also to all such subsequent actions.

THE GRANTOR AND LENDER AGREE THAT THE PROVISIONS OF THIS MODIFICATION OF DEED OF TRUST, AND EACH




