## WARRANTY DEED

KNOW ALL BY THESE PRESENTS that John Strubel

hereinafter called grantor, for the consideration hereinafter stated, to grantor paid by Elmer C. Ogborn and JoAnne M. Ogborn, husband and wife,

hereinafter called grantee, does hereby grant, bargain, sell and convey unto the grantee and grantee's heirs, successors and assigns, that certain real property, with the tenements, hereditaments and appurtenances thereto belonging or in any way appertaining, situated in Klamath County, State of Oregon, described as follows, to-wit:

Lot 42-B of Lakeshore Gardens,

Subject to rights of way for electric powerline  
hereunto granted to the California Oregon Power Company;  
and, reservations and conditions contained in deed from Arthur H. Geary and others to Glenn D. Bowen, dated July 8, 1935,  
recorded November 22, 1935 in Book 105, page 384 Klamath County  
Deed Records and to release from damages due to  
regulation of the water level of Upper Klamath Lake  
granted the California Oregon Power Company by grantors herein.


In construing this deed, where the context so requires, the singular includes the plural, and all grammatical changes shall be made so that this deed shall apply equally to corporations and to individuals.
