Ambers, his wife, Grantee, an undivided one-half interest in the following described real property situated in the County of Klamath, State of Oregon, it being the Grantor's intention to create hereby an estate in the entirety, to-wit:

Parcel 1: The North Half of the Northeast quarter of Section 11, Township 39 South, Range 8 East of the Willamette Meridian, Klamath County, Oregon.

Parcel 2: The E½ of Section 28, Township 32 South, Range 8 East of the Willamette Meridian, SAVING AND EXCEPTING the following described portion thereof: Beginning at the Northeast corner of said Section 28; thence South along the East line of said Section 28 a distance of 1630 feet; thence West and parallel to the North line of said Section 28 a distance of 800 feet; thence North a parallel to the East line of said Section 28 a distance of 1630 feet to the North line of said Section 28; thence East along the North line of said Section 28 a distance of 800 feet to the point of beginning.

Parcel 3: Lots 1, 2, 3, 4, 5, 7, 8, and 9 in Block 1 of UPPER GARDENS ACRES, EXCEPTING THEREFROM that portion deeded to the State of Oregon by and through its Highway Commission in Deed Volume 134 at page 360.

The true and actual consideration for this transfer is a portion of an estate plan.


