

THIS DEED OF TRUST ("Security Instrument") is made on OCTOBER 01ST, 1996. The grantor is MARK E. HAMPTON, MICHELE R. HAMPTON, CHUCK HAMPTON ("Borrower"). The Trustee is FIRST AMERICAN TITLE INSURANCE CO. ("Trustee"). The Beneficiary is FIRST INTERSTATE RESIDENTIAL MORTGAGE, L.L.C., which is organized and existing under the laws of ARIZONA, and whose address is 6000 ATRIUM WAY, MT. LOT 1 IN BLOCK 15, BUENA VISTA ADDITION TO THE CITY OF KLAMATH FALLS, IN THE COUNTY OF KLAMATH, STATE OF OREGON, EXCEPTING THEREFROM THE SOUTH 15 FEET OF SAID LOT.
BEING COMMONLY KNOWN AS 604 MOUNT PITT STREET.
