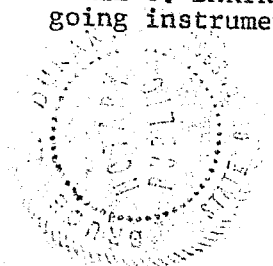

W.M. in Klamath County, Oregon and running thence North along the West line of Section 31 Township 24 S. R. 9 E.W.M., a distance of 793.7 feet to an iron pin which lies on the Easterly right of way line of the Dalles-California Highway 30 feet at right angles from the center line of the highway; thence North 29°02' East following the Easterly right of way line of the Dalles-California Highway a distance of 110 feet to an iron pin; thence at right angles to the center line of the highway South 60°58' East a distance of 660 feet to an iron pin; thence South 29°02' West parallel to the center line of the highway a distance of 680.2 feet to an iron pin set on the old rail fence line which marks the South line of the SW 1/4 NW 1/4 of Section 31 Township 24 S.
