Subject: Barter (Option 1) or Sale (Option 2) of properties described as follows in Arrowhead Village; Block 8 Lot 3 and Block 8 Lot 10. Options 1 & 2 would be solely determined at the Stout's discretion.

Option 1: Acklins would furnish all rock, gravel, and transportation of materials to the Stout's proposed R.V. site, approximately one mile west of the Odessa Mercantile on Highway 140 West. Material would be sufficient enough to complete all roadways, parking lots, R.V. pads, and a gravel filter system to meet or exceed all state and county codes and requirements as well as the weights of various vehicles constructing or utilizing the R.V. park. A reasonable time frame will be agreed upon between the Stouts and Acklins as to when construction will be started and completed at the R.V. site. Upon final inspections and completion the Stouts will convey free and clear title to the Acklins for the above described properties.

Option 2: If for any reason whatsoever the Stouts decide not to construct the R.V. park , or other unforeseen circumstances occur, the Acklins or their heirs agree to pay to the Stouts two thousand dollars (\$2,000.00) within thirty days of written notice by the Stouts and \$203.00 per month for 84 months.
