
A portion of Klamath County Tax Lot No. 3514-03500-01300.

No consideration stated in dollars has been paid for this conveyance.

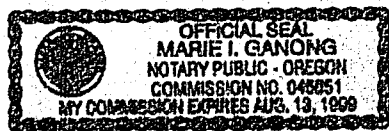


