**PARTIAL RELEASE OF DECLARATION OF TRUST**

WHEREAS, the Klamath Housing Authority (herein called "Local Authority"), entered into Annual Contributions Contract No. S-89, with the United States of America, acting by and through the Secretary of Housing and Urban Development (herein called "Government"), dated January 14, 1980 and Amendment Number 4 thereto, dated October 9, 1987;

WHEREAS, the Local Authority, pursuant to said Annual Contributions Contract and Amendment Number 8 thereto, did execute a Declaration of Trust for Project Number OR-17-03, covering the following described real estate, as well as the real estate that is not affected by this release, situated in the County of Klamath, State of Oregon:

**PARCEL 1:**

Lots 1, 2, 3, 10, 11 and 12, Block 4 FIRST ADDITION TO CHILOQUIN, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon; TOGETHER WITH the E1/2 of the vacated alley adjacent to said Lot 10, vacated by Ordinance #237 recorded October 28, 1963 in Book 349 at page 26, Deed Records.

WHEREAS, said Declaration of Trust was recorded on May 24, 1983, Volume M83, page 8055 of Auditor's records of Klamath County; and

WHEREAS, the Local Authority has proposed and the Government has approved the sale of the above described real property pursuant to the Section 5(h) Implementing Agreement, dated January 22, 1998 between the Local Authority and the Government;

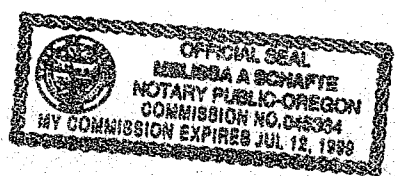
