DEED CREATING ESTATE BY THE ENTIRETY

KNOW ALL BY THESE PRESENTS that PHILIP J. COLLINS

the spouse of the grantee hereinafter named, for the consideration hereinafter stated, does hereby grant, bargain, sell and convey unto DELORES A. COLLINS, hereinafter called the grantee, an undivided one-half of that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or in any way appertaining, situated in KLAMATH County, State of Oregon, described as follows, to-wit:
