## DEED OF RECONVITANCE

KNOW ALL MEN BY THESE PRESENTS, that the undersigned trustee or successor trustee under that certain trust deed dated November 13, 1975, executed and delivered by Bruce W. Nichols & Maria G. 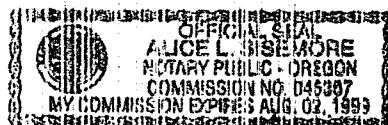
