DEED OF RECONVITANCE

KNOW ALL MEN BY THESE PRESENTS, that the undersigned trustee or successor trustee under that certain trust deed dated July 25, 19 97, executed and delivered by Tom Keller & Mary A. 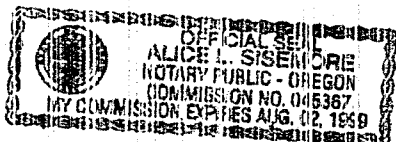
