KNOW ALL MEN BY THESE PRESENTS, that the undersigned trustee or successor trustee under that certain trust deed dated January 12, 1993, executed and delivered by Stephen M. Gorham & Francine R. 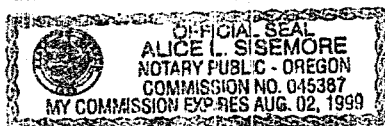
