WHEREAS, Third Party is the owner in fee simple of the following described real property, situate in Klamath County, Oregon, to-wit:

Lot 11, Block 46, HILLSIDE ADDITION to the City of Klamath Falls, according to the official plat thereof on file with the Clerk of Klamath County, Oregon;

(hereinafter referred to as Lot 11, Block 46); and

WHEREAS, Fourth Party is the owner in fee simple of the following described real property, situate in Klamath County, Oregon, to-wit:

Lot 13 and 14, Block 46, HILLSIDE ADDITION to the City of Klamath Falis, according to the official plat thereof on file with the Clerk of Klamath County, Oregon;

(hereinafter referred to as Lots 13 and 14, Block 46), and which said property was previously conveyed by H.C. Head and Cora F. Head, husband and wife, to Richard A. Resare and Sandra L. Resare, husband and wife, by a conveyance wherein H.C. Head and Cora F. Head made the following reservation, to-wit:

Head, husband and wife (First Parties in the Agreement dated April 19, 1965); and Fourth Party as successor in interest to Richard A. Resare and Sandra L. Resare, husband and wife, (Second Parties in the Agreement dated April 19, 1965), all desire to terminate any and all responsibility of the owners of Lots 11, 12 and 15, Block 46, HILLSIDE ADDITION, for the continued operation, maintenance and repair of the well situated on Lot 14, Block 46, and to agree that all such costs, maintenance and repairs shall be the responsibility of the owner of the property legally described as follows, to wit:

WHEREAS, First, Second and Third Parties herein desire to convey unto Fourth Party any interest of First Party, Second Party and Third Party in the hot water well constructed on the said Lot 14, together with one coil therein, as well as the easement described both in the conveyance from H.C. Head and Cora F. Head to Richard A. Resare and Sandra L. Resare, husband and wife, and the aforementioned Agreement dated April 19, 1965;

NOW, THEREFORE, in consideration of the premises, the parties hereto covenant and agree on behalf of themselves, their heirs, successors and assigns, as follows:
