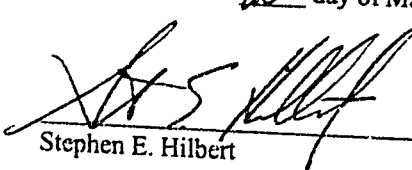

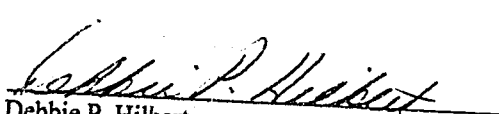

# NOTICE OF CONTINUING USE OF ROAD

STEPHEN E. HILBERT and DEBBIE P. HILBERT, fee title owners of Lot 33, Section 9; SW $\frac{1}{4}$  SW $\frac{1}{4}$  SW $\frac{1}{4}$  and Lot 15, Section 10; W $\frac{1}{2}$  NW $\frac{1}{4}$  NW $\frac{1}{4}$  and NW $\frac{1}{4}$  SW $\frac{1}{4}$  NW $\frac{1}{4}$  of Section 15; and Lots 1, 10, and 11, Section 16; all in Township 35 South, Range 7 E.W.M., Klamath County, Oregon, give notice of their continuing use, under claim of right, of the roadway constructed by the United States to provide access to allotments granted to members of the Klamath Indian Tribes, including Mary Ottegal, who received as an allotment the land described above by instrument recorded September 10, 1958 in Volume 303 of Page 332 of the Deed Records of Klamath County, Oregon. Said roadway is shown on the map attached hereto and crosses Lots 20, 21, 30, 31, and 40 of Section 16, the W $\frac{1}{2}$  W $\frac{1}{2}$  SW $\frac{1}{4}$  and SW $\frac{1}{4}$  SW $\frac{1}{4}$  NW $\frac{1}{4}$  of Section 15 and the NE $\frac{1}{4}$  of Section 21, Township 35 South, Range 7 E.W.M., Klamath County, Oregon. The existence of said road and the right to use said road was acknowledged in and reserved in the patents from the United States of America to the initial private owners of said lands. Said road is also referred to in the Deed recorded March 10, 1961 in Volume 328 at Page 28 of the Deed Records of Klamath County, Oregon.

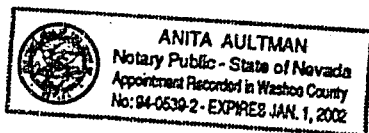

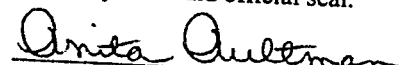

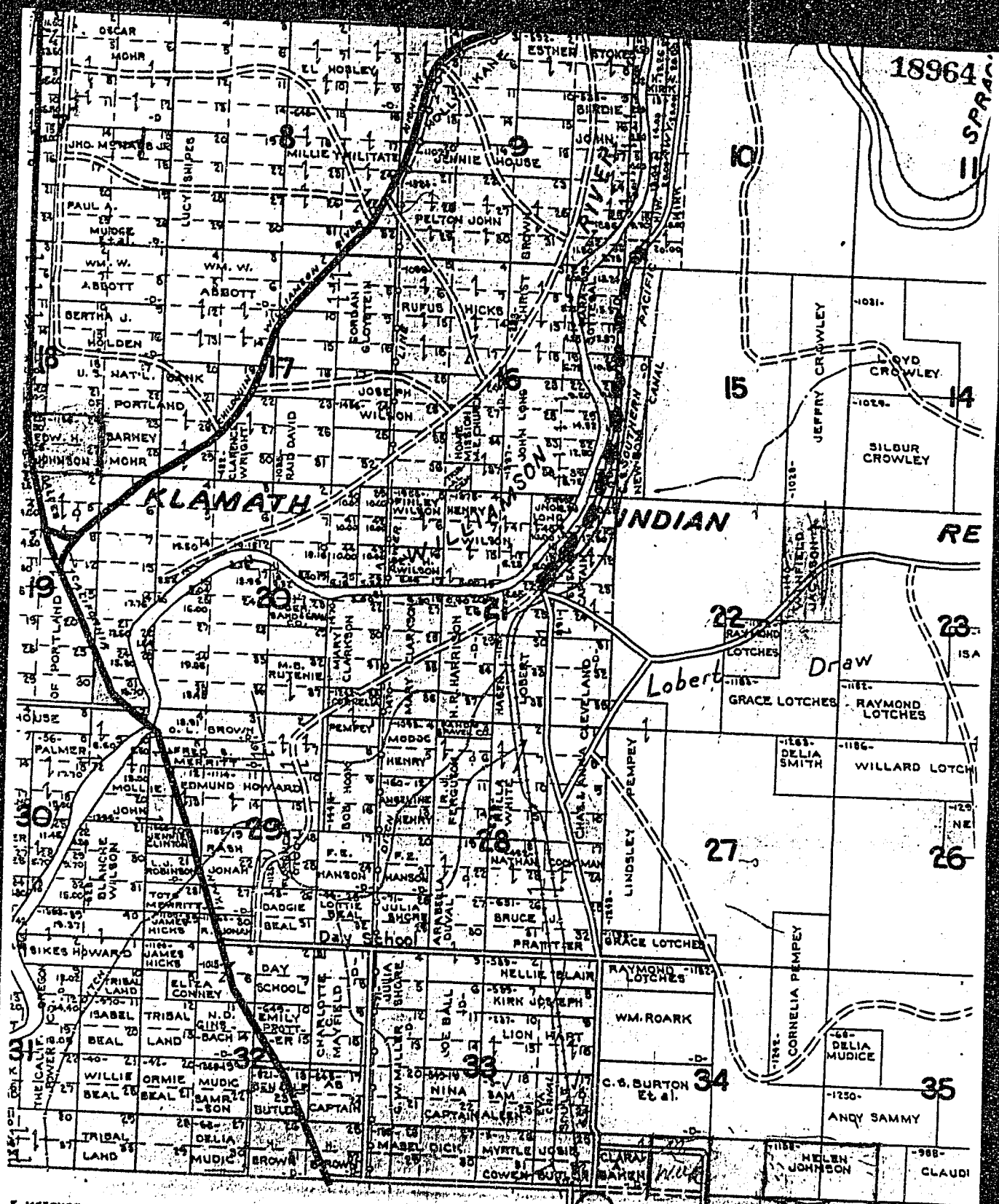
