FARGAIN AND SALE DEED

KNOW ALL MEN BY THESE PRESENTS, that, Gilbert L. Morey and Eva L. Morey, husband and wife, hereinsfler called the Grantors, for the consideration hereinafter stated, does hereby grant, bargain, sell and convey unto, Sheridan W. Lee and Yanis J. Lee, husband and wife, hereinafter called Grantees, and unto Grantee's heirs, successors, and assigns an undivided one-half interest as tenants by the entirety. In and to that certain real property with the tenements, hereditaments and appurtenances thereunto belonging or in anywise appertaining, situated in the County of Klamath, State of Oregon, described as follows, to-wit:

North half of Government Lot 6, Section 12, Township 38 South, Range 8 East of the Willamette Meridian, EXCEPT a tract described as follows: Beginning at the high water mark of Klamath Lake and the Northwest corner of Lot 6; thence East along the North line of said lot, 160 feet; thence South 50 feet; thence West to the high water mark of Klamath Lake; thence North along said Klamath Lake to the point of beginning.

To have and to hold the same unto the said Grantees and Grantee's heirs, successors and assigns forever.

It is Grantor's intention to retain an undivided one-half interest in the premises as tenants by the entirety.

The true and actual consideration paid for this transfer, stated in terms of dollars, is OTHER CONSIDERATION. This is a transfer for estate planning purposes.

In construing this deed and where the context so requires, the singular includes the plural and all grammatical changes shall be implied to make the provisions hereof apply equily to corporations and to individuals.

THIS INSTRUMENT WILL NOT ALLOW USE OF THE PROPERTY DESCRIBED IN THIS INSTRUMENT IN VIOLATION OF APPLICABLE LAND USE LAWS AND REGULATIONS. BEFORE SIGNING OR ACCEPTING THIS INSTRUMENT, THE PERSON ACQUIRING FEE TITLE TO THE PROPERTY SHOULD CHECK WITH THE APPROPRIATE CITY OR COUNTY PLANNING DEPARTMENT TO VERIFY APPROVED USES AND TO DETERMINE ANY LIMITS ON LAWSUITS AGAINST FARMING OR FOREST PRACTICES AS DEFINED IN ORS 30,930.
