ti Upon any default by granter of if all or legislar of the property is sold or transferred by granter agricult beneficiary a consent, the baneficiary may at any time, without notice, either in person or by agent, and without regard to the adequacy of any security for the indebtenness secured, either upon and take possession of the property or any part of it, and that the entering upon and taking possession of the property shall not cure or waive any default or notice of default or invalidate any act done pursuant to such notice.
