- 3 1. The first and final account is approved as filed.  
4 2. The Personal Representative is directed to reimburse  
5 himself for costs advanced by him in the amount of \$309.81.  
6 3. The Personal Representative is directed to make distribution  
7 of the remaining estate property to CAROLYN K. COUNTRYMAN as  
8 follows, to-wit:

9 Undivided one-half interest in the following described real  
10 property, situated in Klamath County, Oregon, to-wit:

11 Parcel A: Lots 5, 6, 7, and 8, together with the West 3 feet of  
12 vacated alley abutting on the east of Lots 5, 6 and the South ½  
13 of Lot 7, in Block 31, City of Merrill, Klamath County, Oregon.

14 Parcel B: Beginning at a point on the line between Sections 10 and 11,

Lot 3, Block 31, in the Town of Merrill, a platted portion of Klamath  
County, from which the monument marking the Southwest corner of Lot 4 of
