# ATC- 47931 EASEMENT

Arlene Ross, Grantee, in consideration of the sum of \$500, receipt of which is hereby acknowledged, hereby grants to Andrew A. Patterson and the Trustees of the William M. Ganong Profit Sharing Plan Trust, Grantees, their successors and assigns, an easement for sewer in and across a strip of land eight feet in width being the easterly eight feet of the following described real property, to-wit:

> Beginning at a point which is 1,097.5 feet Northerly and 990.0 feet Easterly of the Southwest corner of the NW14 of Section 1, Township 39 South, Range 9 East of the Willamette Meridian. Klamath County, Oregon, also known as Saylor's corner; thence South 89°58' East 65.0 feet; thence North 00°02' East, 100.0 feet to a point on the Southerly boundary of Climax Street; thence North 89°58' West along the Southerly boundary of Climax Street 65.0 feet; thence South 00°02' West 100.0 feet to the point of beginning. together with the right to use so much of the adjoining land as is reasonable and necessary in connection with the original construction of the sewer.

1. The Grantees and the agents and employees of the Grantees shall have the privilege of entering upon said premises for the purpose of constructing and making necessary repairs to or changes to said sewer.

2. The said sewer shall be placed underground in the usual manner and Grantees agree to replace the surface of the ground above the sewer in as good a condition as its present condition and agree that Grantor shall have full and unrestricted use of the surface of said ground except during the period of sewer construction and during the period of any repairs that may be necessary.

3. That Grantor may park automobiles on the easement area and store auto parts and other personal property on the easement area except during the period of construction and during any period of repairs. Grantor shall promptly remove any automobiles or other personal property upon request from Grantee to allow Grantee to construct, repair, or replace the sewer.

This Easement is appurtenant to the land of Grantees described on Exhibit A attached hereto and shall inure to the benefit of Grantees' successors and assigns.
