QUITCLAIM DEED

KNOW ALL BY THESE PRESENTS that Klamath County, a Political sub-division of the State of Oregon

hereinafter called grantor, for the consideration hereinafter stated, does hereby remise, release and forever quitclaim unto Bly Vector Control District, an Oregon Municipal Corporation

hereinafter called grantee, and unto grantee's heirs, successors and assigns, all of the grantor's right, title and interest in that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or in any way appertaining, situated in Klamath County, State of Oregon, described as follows, to-wit:

Lots 4, 5, 6 and the Sely 10'-8" of Lot 14 and the NWly 34' of Lot 15, Block 1, North Bly, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon.

SUBJECT TO the condition that the named Grantee construct an equipment and material storage facility within five (5) years from the date of recording this Quitclaim deed. In the event the Grantee does not construct an equipment and material storage facility within five (5) years, then the above described real property shall revert to the Grantor herein.

To Have and to Hold the same unto grantee and grantee's heirs, successors and assigns forever.

The true and actual consideration paid for this transfer, stated in terms of dollars, is \$1,001.00. In construing this deed, where the context so requires, the singular includes the plural, and all grammatical changes shall be made so that this deed shall apply equally to corporations and to individuals.


