real property, with the tenements, hereditaments and appurtenances thereunto belonging or in any way appertaining, situated in
Klamath County, State of Oregon, described as follows, to-wit:

Lot 19, Block 7, Tract 1060-Sun Forest Estates, according to the official
plat thereof on file in the office of the County Clerk of Klamath County,
Oregon.

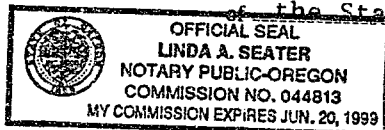
