hereinafter called grantor, for the consideration hereinafter stated, does hereby remise, release and forever quitclaim unto

hereinafter called grantee, and unto grantee's heirs, successors and assigns, all of the grantor's right, title and interest in that certain
real property, with the tenements, hereditaments and appurtenances thereunto belonging or in any way appertaining, situated in
Klamath County, State of Oregon, described as follows, to-wit:

The South 435.40 feet of the East 1035 feet of Lot 16, Block 10, Klamath
Falls Forest Estates Sycan Unit also known as Lot 16 E, Block 10, Klamath
Falls Forest Estates Sycan Unit, according to the official plat thereof on

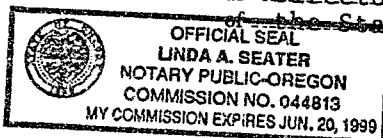
