KNOW ALL BY THESE PRESENTS that Klamath County, a Political sub-division of

hereinafter called grantor, for the consideration hereinafter stated, does hereby remise, release and forever quitclaim unto
N. Mark Gohlke & Margaret Grace, Not as Tenants in Common, but with Full
hereinafter called grantee, and unto grantee's heirs, successors and assigns, all of the rights of Survivorship
real property, with the tenements, hereditaments and appurtenances thereunto belonging or in any way appertaining, situated in
Klamath County, State of Oregon, described as follows, to-wit:

Lot 22, Block 44, First Addition To Klamath Forest Estates, according to
the official plat thereof on file in the office of the County Clerk of
Klamath County, Oregon.

SUBJECT TO Covenants, conditions, reservations, easements, restrictions,

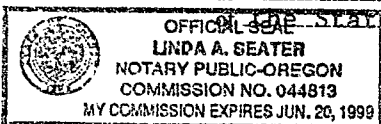
