which), conveying real property situated in that county described as follows:



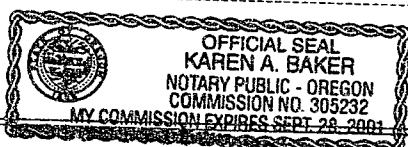
