1. NATURE OF THE ASSERTED VIOLATION

Respondent is alleged to have been camping as defined by Article 11, in addition Respondent is alleged to have located buildings without obtaining the necessary clearances for occupancy.

2. NAMES OF PARTICIPANTS

3. LOCATION OF PROPERTY INVOLVED

The property is located on Brown Bear Lane, Bly Mountain, Klamath County

4. EVIDENCE RECEIVED

All evidence consisted of the oral testimony given June 5, 1998 and the attached exhibit A.

5. FINDINGS OF FACT

The Hearings officer FINDS AS FOLLOWS:

- a. The respondents did appear.
- b. That the Respondents have been camping and building un-permitted structures on the subject property.
- c. That the Respondents are making significant progress towards getting the situation remedied. And can have all necessary inspections and permits in place by June 30, 1998.

6. ORDER

THEREFORE, IT IS HEREBY ORDERED THAT:

The hearings officer finds that as a matter of law the Respondent is in violation of the Klamath County Land Development Code.

The Respondents shall bring proof of all necessary permits and inspections to the Klamath County Enforcement Officer by June 30, or shall cease camping and to remove all un-permitted structures and personal property no later than June 30, 1998.
