A Tract of Land situated in Sections 25 and 36, Township 37 South, Range 7 East, W.M., Section 1, Township 38 South, Range 7 East, W.M., and Section 6, Township 38 South, Range 8 East, W.M., Klamath County, Oregon, more particularly described as follows:

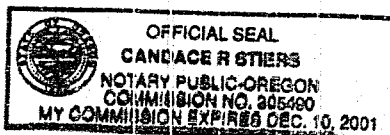
