There is no dwelling presently sited on this parcel but applicant wishes to build a stick home on the property and reside in the trailer until the stick built home is completed. 6. ORDER Therefore, it is hereby ordered that the applicants request to develop a second residence on her 10 acres is denied. However, applicant is permitted to install a temporary trailer, mobile or other structure without a permanent foundations, and on a temporary basis while she builds her home

- a. That any structure be temporary in nature and not be located on the property more than 30 b. Than in no case shall a temporary dwelling be located on the property past July 30, 1999.
