NOTICE OF CLAIM OF LIEN UPON CHATTELS

NOTICE IS HEREBY GIVEN that James Holmes, hereinafter called claimant, claims a lien upon a 1990 Ford F150 4X4 pickup, Oregon license No. TRF881, for labor performed, services rendered and/or materials furnished in the alteration, repair, transportation and/or storage of the above described chattels in Klamath County, Oregon. The labor, services and/or materials are described as follows:

Repair frame, remove and replace engine for frame repair, remove and replace steering gear, unbolt front suspension, remove and replace cross member, repair cracks in frame, reconnect front suspension, adjust alignment and center steering wheel.

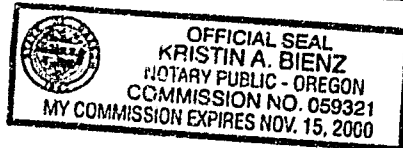
