QUITCLAIM DEED

KNOW ALL BY THESE PRESENTS that Abraham L. Boehm

hereinafter called grantor, for the consideration hereinafter stated, does hereby remise, release and forever quitclaim unto Abraham L. Boehm, Michael E. Ross with right of survivorship hereinafter called grantee, and unto grantee's heirs, successors and assigns, all of the grantor's right, title and interest in that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or in any way appertaining, situated in Klamath County, State of Oregon, described as follows, to-wit:

A parcel of land situated in Lot 2 of Section 28, Township 40 South, Range 9, E.W.M., and more particularly described as follows: Beginning at a point on the East line of said Lot 2 which is $S 0^{\circ}02'15'' E$ a distance of 1320.0 feet from the North East Corner thereof, said point also being the Southwest corner of the $NE \frac{1}{4} NE \frac{1}{4}$ of said Section 28; thence continuing $S 0^{\circ}02'15'' E$, along the East line of said Lot 2, a distance of 499.5 feet, more or less, to the Northerly right-of-way line of the Lower Klamath Lake Road; thence $N 69^{\circ}35' W$, along said Northerly right-of-way line a distance of 533.5 feet to the East line of that certain parcel of land conveyed to Oscar A. DeNault, et ux, by Deed Volume 320, Page 125, records of Klamath County, Oregon; thence $N 06^{\circ} E$, along said East line, to a point that is East a distance of 495.6 feet, more or less; ~~thence East 353.5 feet to the point of beginning; said parcel containing 4.0 acres, more or less, except the Easterly 20 feet there of.~~ from the Point of Beginning; thence East 495.6 feet to the Point of Beginning, except the Easterly 20 feet there of.


In construing this deed, where the context so requires, the singular includes the plural, and all grammatical changes shall be made so that this deed shall apply equally to corporations and to individuals.
