INDENTURE OF ACCESS

THIS INDENTURE, made and executed this 28½ day of 1998, by and between the STATE OF OREGON, by and through its DEPARTMENT OF TRANSPORTATION, hereinafter called "State", and KAREN J. DEMARIS, Successor Trustee of the Betty J. Ahern Living Trust u.d.d. September 27, 1989, hereinafter called "Owner".

WHEREAS, State by deed recorded May 6, 1953, in Book 260, Page 484, Klamath County Deed Records, acquired from Jacob Wm. Schabener and Grace Schabener, husband and wife, certain property situated in the (S1/2) of Section 24, and the (NE1/4) (NW1/4) of Section 25, Township 23 South, Range 9 East, W.M., Klamath County, Oregon, which deed, in part, reserved access rights, for the service of said grantor's remaining property, to and from the West side of the relocated The Dalles - California Highway, opposite Engineer's Station 1145+00; and

WHEREAS, Owner, by bargain and sale deed recorded in Volume M89, Page 1872, Klamath County Deed Records, acquired fee title to that portion of said remaining property affected by the access changes herein made; and

WHEREAS, Owner has requested that Owner's access rights opposite said Station 1145+00 be terminated, and that access rights be substituted, therefor to and from the West side of said highway opposite Engineer's Station 1161+84; and

WHEREAS, State is agreeable to the granting of Owner's request.

NOW THEREFORE, THIS INDENTURE WITNESSETH, that for and in consideration of the grant hereinafter made by State, OWNER does transfer and relinquish unto State, its successors and assigns, Owner's access rights to and from the West side of the relocated The Dalles - California Highway opposite said Station 1145+00, reserved in said deed recorded May 6, 1953. Owner represents and warrants that no one, other than Owner, is using or entitled to use the access rights herein relinquished. STATE, in consideration of the relinquishment and warranties herein made, does grant access rights unto Owner and owner's heirs, successors and assigns, to and from the West side of said highway, opposite said Station 1161+84, in a width of 35 feet, and unrestricted as to use.
